The committee shall also receive the intention letter for the Office of International Director endorsement at the District Convention.

The nominations so received shall be scrutinized by the Nomination Committee at least Seven (7) days prior to the commencement of the Annual District Convention and the Candidate/sponsoring club shall be informed in writing, if any technical mistake is noticed or details are found lacking in the nomination. The Candidate/sponsoring club shall be requested to make necessary corrections of the same within Five (5) days as stipulated by the Nomination Committee in writing to the Candidate /sponsoring club concerned.

### International Constitution and By-Laws revised in June 2023

#### **Article IX - District Conventions and Elections**

##### **Section 4 Candidate Requirements for District Governor.**

**A candidate for the office of district Governor shall :**

- ☐ Be an active member in good standing of a Chartered Lions Club in good standing in his / her single or sub-district.
- ☐ Security endorsement of his/her club or a majority of the clubs in his / her single or Sub - District.
- ☐ Currently be serving as the first Vice district Governor within the district from which he/she is to be elected.
- ☐ Only in the event the current First Vice District Governor does not stand for election as District Governor, or if a vacancy in the position of First Vice District Governor exist at the time of the District convention, any club member who fulfills the qualifications for the office of the Second Vice District Governor as set forth in these by-laws or constitution and who is currently serving or who has served one (1) additional year as a member of the district cabinet, shall fulfill the requirements of sub section (c) of this section.

### Section -6(b)- A candidate for the office of First Vice District Governor shall:

- ☐ Be an active member in good standing of a Chartered Lions Club in good standing in his/her single or sub-district.
- ☐ Secure the endorsement of his/her club or a majority of the clubs in his/her single or sub-district.
- ☐ Currently be serving as the Second Vice District Governor within the district from which he/she is to be elected.
- ☐ Only in the event of the current Second Vice District Governor does not stand for the election as First Vice District Governor, or if a vacancy in the position of Second Vice District Governor exists at the time of the district convention, any club member who fulfills the qualifications for the office of Second Vice District Governor set forth in these by-laws or constitution shall fulfill the requirements of subsection (3) of this section

### Section - 6 (c)A candidate for the office of Second Vice District Governor shall:

- ☐ Be an active member in good standing of a Chartered Lions Club in good standing in his/her single or sub-district.
- ☐ Secure the endorsement of his / her club or a majority of the clubs in his / her single or sub-district.
- ☐ Have served or will have served at the time he / she takes office as second vice district governor.
  - (a). As president of a Lions Club for a full term or major portion thereof, and a member of the board of directors of a Lions Club for not less than two (2) additional years.
  - (b). As a Zone Chairperson or Region Chairperson or Cabinet Secretary or Treasurer for a full time or major portion thereof.
  - (c). With none of the above be accomplished concurrently.

### Withdrawal of Nomination

In accordance with rules of procedure mentioned in our District Constitution & By- Laws under the head Convention, Rule 4 (b) , candidate may withdraw from the contest at any time prior to the issuance of the final report of the nomination committee.

After the nominations for the offices of the District Governor, First Vice District Governor & Second Vice District Governor are closed and the nomination committee recommends the holding of elections to the offices, it is the duty and responsibility of the election committee to conduct the elections as per District, Multiple District and International Constitution and By- laws.

### **Election of District Governor & First Vice District Governor**

The District Governor & First Vice District Governor election shall be conducted by a secret written ballot. The District Governor and First Vice District Governor Candidate required to secure a simple majority of the affirmative votes cast by the delegates present and voting in order to be declared elected. For the purpose of such election, a majority is defined as a number more than one half of the Total valid votes cast.

### **Election of Second Vice District Governor**

- (a) In the case of Second Vice District Governor, if there is only one candidate, the election procedure shall be the same that of the District Governor / First Vice District Governor. Alternatively,
- (b) If there are two candidates for the office of Second Vice District Governor, the election shall be conducted based on the secret ballot in which the name of the candidate appears in English alphabetical order. The Candidate who secures at least one vote in excess of 50% of valid polled.
- (c) Alternatively, If there are more than two candidates for office of Second Vice District Governor, the election shall be conducted based on the secret ballot in which the names of the candidates appears in English alphabetical order. The candidate who secures at least one vote in excess of 50% of valid votes polled shall be declared as elected, However.
- (d) If none of the candidate secures majority (i.e.. one vote over and above the 50% of valid votes polled) the candidature of the top two vote toppers alone shall be retained and the candidature of the others shall be eliminated from further electoral process
- (e) After the elimination process as defined above fresh election shall be conducted as per item (b) above

The Election Committee can give the guidelines which are necessary and deem fit for conducting a free and fair election. The Election Committee will be incharge of balloting and counting of votes and the District Governor shall declare the results of the elections to the general body.
